Adoption of a new Constitution of the Society

A motion will be proposed to adopt a new constitution in the place of the existing constitution. Set out below is a summary of the few changes to which the new constitution will give effect. However as these changes will give rise to changes to the wording in various places in the document and rather than setting out all these wording changes in the text of the motion, it is more simple that the motion proposed is that an entire new document be adopted. The following are the significant changes in the revised Constitution –

- As explained in the HCCPS newsletter, it is proposed that the rule stating that the AGM be held within 2 months of the end of the financial year be changed to 7 months from the year end. This is to allow the AGM to be held in the Spring when the daylight/weather may allow more members to attend and participate at the AGM. The rules will continue to say that the statement of accounts will be made up for the period from 1stNovember to 31st October, so the year end will not change and it is the intention of the Committee that the examined accounts to 31st October will be available on the Society' website by the end of December in that year
- It follows that it is the Committee's intention that the next AGM following this meeting will be in April or May of 2023, with the consequence that the Committee and Officers confirmed in office at the AGM in 2021 will serve for an extended period (ie to the AGM in 2023).
- The present rule about the operation of the Society's bank accounts merely stipulates who may sign cheques (the Treasurer and any other Committee member). The wording is being changed to reflect more up-to-date banking practices and to allow any two Committee members to authorise payments etc.
- 4 The opportunity is taken to include rules allowing for General Meetings of Members and of Committee meetings to be conducted remotely by video and other technology.



5 The rule stipulating that only Members of the Society may speak and vote at a General Meeting is clarified to ensure that only members up-to-date in paying their subscriptions may speak and vote.
